Treasurer Report: \$4620.02

Old Business: This season we opted to switch from binded books to binders which saved \$1400 of the sponsorship fees and agreed to take \$600 from it to provide top female at \$200 each for mixed teams divisions, and continuing with payouts as usual then adjusting top shooter to top male. Late envelopes \$15.00 for Scotch and \$25.00 for Mixed.

New Business: Discussed the new Facebook page, using it to make announcements, FAQs posts, and posting schedules. Staying on top of unsportsmanlike conduct this season. STRESSING the fact that players must communicate with the board in order to stay informed and intervene when necessary.

Captain's Meeting: We went over key rules, went over payouts and that top male will take the place of top shooter, and with saving \$1400 on switching to binders we will take from that to add \$200 for top female to each mixed teams division. Informed captains that binders have to be turned back in at the end of the season and be in reusable condition or they will be fined \$20. We stated the late fees, reminded captains about players being late resulting in a forfeit, and stressed that they communicate with us throughout the season so we can intervene when needed instead of waiting until later. We demonstrated and discussed open communication in Scotch.
